

**Tom & Chee Melt Jackpot Giveaway
OFFICIAL RULES**

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN THIS SWEEPSTAKES. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**
2. **Eligibility.** Subject to the additional restrictions below, Tom & Chee Melt Jackpot Giveaway (the "Sweepstakes") is open to participants who are legal residents of the US.
