

**Tom & Chee Melt Jackpot Giveaway  
OFFICIAL RULES**

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN THIS SWEEPSTAKES. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**
2. **Eligibility.** Subject to the additional restrictions below, Tom & Chee Melt Jackpot Giveaway (the "Sweepstakes") is open to participants who are legal residents of the US. Employees of TCWW, LLC ("Sponsor") and its affiliated companies, subsidiaries, and advertising and promotional agencies, and the family members of, and any persons domiciled with, any such employees, are not eligible to enter or to win.
